**Re: Proposal to establish a new primary school on the Glan Llyn development**

Newport City Council has today launched formal consultation on a proposal to establish a new English-medium primary school in Newport for pupils aged between 3 and 11 years, on the Glan Llyn development, with effect from September 2018.

In order to help the Council in reaching a decision on this proposal, we are inviting you to have your say by engaging in our statutory consultation. **The consultation period will commence today, 2<sup>nd</sup> October 2017 and close on 12<sup>th</sup> November 2017.**
