- Concessionary seat allocation will not be reviewed until the following year.
- All payments must be received in advance before any travel will be granted each term.

**NOTES FOR GUIDANCE**

- There is no right to appeal if you are not awarded a concessionary seat because it is not a statutory requirement to offer concessionary seats.
- Applicants will only be considered on the current concessionary seats on contracted home to school transport application form. No applications will be considered before all entitled applicants have been dealt with.
- If there are more applicants than available seats, the seats will be strictly allocated on a first come, first served basis.
- Pick up / drop off points will only be on existing routes as we are unable to divert vehicles or change routes.
- Pupils carried on concessionary seats are carried under the same terms and conditions as entitled pupils and must adhere to the *Home to School/College Transport Code of Good Practice* at all times.
- Where there is a change of family residence, concessionary permits must be returned to the address below. Parents may re-apply for concessionary travel from their new address subject to availability of spare seats and the above criteria.
