Os lleihawyd eich bil dan CGDG, mae eglurhad manwl o'r rhesymau dros y lleihad yn llythyr hysbysiad CGDG, a allai gael ei anfon ar wahân. Os yw'r dyfarniad CGDG gyfwerth â 100% o'ch bil, mae eich annedd wedi'i heithrio rhag y dreth gyngor. Rydym wedi cynryd yn ganiataol y bydd eich hawl i CGDG yn parhau gydol y flwyddyn filio. Mae dyletswydd arnoch i roi gwybod yn ysgrifenedig i Reolwr Budd-daliadau'r Cyngor, o fewn 21 diwrnod, am unrhyw newid mewn amgylchiadau a allai effeithio ar eich hawl i gael gostyngiad. - os ydych chi neu unrhyw un sy'n byw gyda chi yn dechrau gwaith.

Nid rhestr gynhwysfawr yw hon. Os ydych yn ansicr, gofynnwch i'r Cyngor am gyngor. Mae'n drosedd i beidio â dweud wrth y Cyngor am unrhyw newidiadau a allai effeithio ar eich gostyngiad. Gall y Cyngor gymryd camau cyfreithiol yn eich erbyn, ac os cechw ormod o ostyngiad bydd rhaid i chi ei ad-dalu.

WHY PAY MORE THAN YOU HAVE TO?

If you are the only adult resident in your home you may claim a 25% discount. Some adults may be 'disregarded' and some dwellings may be exempt. More details about reductions are contained in the Explanatory Notes within the Information referred to above, at www.newport.gov.uk/counciltax. Application forms may also be found there.

If you are on low income, you should make an application under the Council Tax Reduction Scheme. This is a means-tested reduction, and you may complete an online enquiry form, or request a form by e-mail at www.newport.gov.uk/counciltax - go to 'You Can Claim'.

CHANGES IN CIRCUMSTANCES: COUNCIL TAX LIABILITY

This notice assumes that the conditions of your liability, including entitlement to discount and other reductions, will continue for the whole of the billing year. You have a duty to notify the Council within 21 days of any changes which may affect your Council Tax liability. For example: changes of address; entitlement to a reduction. Failure to do so without reasonable cause may result in a £50 penalty. Telephone 01633 656656 or go to www.newport.gov.uk/counciltax

COUNCIL TAX REDUCTION SCHEME (CTRS)

If your bill has been reduced under the CTRS, a detailed explanation of the reasons for the reduction is contained in your CTRS notification letter, which may be sent separately. If the CTRS award is 100% of your bill, your dwelling is exempt from council tax. An assumption has been made that your CTRS entitlement will continue for the whole of the billing year. You have a duty to notify the Council's Benefits Manager in writing, within 21 days, of any change of circumstances which might affect your entitlement to a reduction. Examples of changes of circumstances that you must report are when:

- any of your children leave school or leave home;
- anyone moves into or out of your home, including lodgers and subtenants;
- your income or the income of anyone living with you, including benefits, changes;
- your savings or investments change;
- you move;
- you or your partner are going to be away from home for more than a month;
- you or anyone living with you start work.

This is not a full list. If you are not sure ask the Council for advice. It is an offence not to tell the Council about any changes that may affect your reduction. The Council may take Court action against you and if you receive too much by way of a reduction you will have to pay it back.
