Notice is hereby given that pursuant to Sections 29 and 30 of the Public Audit (Wales) Act 2004 and the Accounts and Audit Regulations (Wales) 2014:-

1. From 11<sup>th</sup> July 2016 to 5<sup>th</sup> August 2016, inclusive (but excluding each Saturday and Sunday) between 9.00am and 4.30pm any person interested, on application to the Assistant Head of Finance, Newport City Council, Civic Centre, Newport, Gwent, NP20 4UR may inspect and make copies of the accounts of the above named Council for the year ended 31<sup>st</sup> March 2016, and all books, deeds, contracts, bills, vouchers and receipts relating thereto. On or after Monday the 8th of August 2016 at 9.00am, the Council's External Auditor, at the request of a local government elector for the area to which the accounts relate, will give the elector or his representative the opportunity to question him about the accounts and any such elector or his representative may attend before the Auditor at Newport City Council, Civic Centre, Newport, Gwent, NP20 4UR and make any objection to any of the accounts.

No objection may be made under paragraph 2 above unless prior written notice of the proposed objection and the grounds on which it is made has previously been received by both the External Auditor at (Wales Audit Office, 24 Cathedral Road, Cardiff, CF11 9LI] and by the Assistant Head of Finance, Newport City Council, Civic Centre, Newport, Gwent, NP20 4UR.
