2. Nomination papers may be obtained from the offices of the Returning Officer, Room 528, Civic Centre, Newport, during the times stated above.
3. If any election is contested the poll will take place on 16/04/2020.
4. Applications to register to vote must reach the Electoral Registration Officer by 12 midnight on 27/03/2020. Applications can be made online: <https://www.gov.uk/register-to-vote>.
5. Applications, amendments or cancellations of postal votes must reach the Electoral Registration Officer at Room 528, Civic Centre, Newport by 5 p.m. on 30/03/2020.
6. Applications to vote by proxy at this election must reach the Electoral Registration Officer at Room 528, Civic Centre, Newport by 5 p.m. on 06/04/2020.
7. Applications to vote by emergency proxy at this election on the grounds of physical incapacity or for work/service reasons must reach the Electoral Registration Officer at Room 528, Civic Centre, Newport by 5 p.m. on 16/04/2020. The physical incapacity must have occurred after 5pm on 06/04/2020. To apply on the grounds of work/service, the person must have become aware that they cannot go to the polling station in person after 5pm on 06/04/2020.
