## **1. Name and description of the policy / proposal being assessed. Outline the policy's purpose.**

### **Family Support Services – Barnardo's Partnership**

There is a long-standing partnership with Barnardo's to deliver Family Support Services for children and families at the edge of care.

The service provides a wide range of interventions supporting children families who are at risk of child protection processes and legal interventions. 85% of the families supported at the end of the work demonstrate reduced risk.

Reducing the overall budget does create a saving for Newport City Council. Whilst the service recognises that this reduction could result in a reduction to support to families it believes the risk is manageable.

The proposal is to reduce the budget by £167k, which will mean a staff reduction for Barnardo's and then a lower capacity to accept referrals. Currently the service is working to deliver a wide range of interventions directly to families who are at risk of greater intervention from Children's Services. Social workers work with Barnardo's staff to give families positive ways to manage their family challenges for example substance misuse, domestic violence, parental mental ill health, neglectful parenting and then offer safer family life for their children.

If the proposed saving is agreed the service will work to prioritise the services offered to consider the lowest level of impact.

The Council wide consultation in respect of the savings proposals is currently ongoing. These proposals are included within the wider consultation.

**3. What information/evidence do you have on stakeholders? e.g. views, needs, service usage etc. Please include all the evidence you consider relevant.**

Children’s Services provides statutorily required services for children and their families. During recent consultations for the CIW inspection the views of those accessing services were positive and overall reflected a high level of direct engagement and involvement from staff. Children and families were well informed and were aware of the elements of service provision.

Within families there can be conflicting views of services provided by Children’s Services because of the nature of the involvement with work driven by child protection and set within the court arena.

Children’s Services receives between 850 and 1100 referrals a week. There are currently 120 children on the Child Protection register, 390 children looked after and 40 children involved in court proceedings. At any one time Children’s Services will directly be supporting around 2500 children and their families. The majority of this involvement will involve some element of statutory engagement.

The proposal for the savings linked to Barnardo’s will reduce the capacity of the service to provide a response but the reduction has been minimised by considering the services provided and tailoring support services.
