Item

- 1 Apologies for Absence**
Chris Heap (NRW), Les Handy, Jo Evans, Anna Harris
- 2 Involving Community Councils in PROW**
The meeting discussed how closer working with Community Councils could be achieved in order to improve RoW network. There are approximately 15 community councils in the Newport area. There is a quarterly Liaison Meeting of Community Councils and it was recommended that Luke could attend one of these meetings. This would start to build a closer relationship and clarify the responsibilities and powers that Community Councils have with regard to public rights of way.
- 3 LAF contribution to Newport City Council**
Luke asked the attendees how they would like to contribute. Ideas put forward were as follows:
 - Build closer links to walking groups
 - Active participation in a survey of the rights of way network – use the CAMs survey forms
 - Help to set clear, measurable goals for the year for the LAF? E.g. % of network that is passable
 - Identify problem paths that need to be cleared every year so that maintenance can be scheduled without being asked.
 - Housing developments are reducing the rights of way network – help to reduce impact
 - Improve the user evidence forms (Anne Underwood has some forms from other areas which might be useful).
 - The “Living Levels” initiative is looking to create circular routes in the Gwent levels (Jo Gossage) – the LAF might be able to help with this.

- Help to gather evidence to create/upgrade rights of way. E.g. "Enclosure Orders" can be used as evidence of a public right of way. As can details in the Finance Act 1920 of highways.
- Anti social use of the RoW network by 4x4s and motorbikes was discussed.

4 **ROWIP Review Update**

Luke, Debbie and Anne gave feedback from the first sub committee of the LAF ROWIP Update which was held on Thursday 15th February. Subjects covered include:

- How to prioritise resources for the RoW network.
- Use of drones to survey paths (and identify path abuse)
- Recording paths before the 2026 deadline (how to gather and present evidence).
- Ploughing/cropping – reporting areas where paths are not restored within 14 days
- Unclassified paths – could we look at improving/utilising them?
- Lack of a furniture standard policy for Newport – could this be created as part of the ROWIP. How to encourage landowners to put in gates rather than stiles to improve access.

5 **Any other business**

- John has seen a map of possible fracking areas which includes some in Newport wetlands
- Doug mentioned that a "heritage trail" was proposed to take in historical sites from Newport via Caerphilly to Cardiff. Also a chartist heritage route from Blackwood to Newport (via Rogerstone)
- Everyone to look out for any news on these proposals
