Proposal to establish a new primary school on the Glan Llyn development

The full statutory consultation process has now concluded on the proposal by Newport City Council to establish a new two-form entry English-medium primary school on the Glan Llyn development.

The formal consultation document was prepared outlining a proposed implementation date of September 2018. However the consultation report recommended modifying the implementation date to September 2019, and the statutory proposal was published outlining the revised date.

15 objections were received during the statutory proposal stage and as a result the final determination was referred to full Cabinet. I am pleased to confirm that Cabinet took the decision to implement the proposal as outlined within the statutory notice. **The new school will therefore open in September 2019.**
