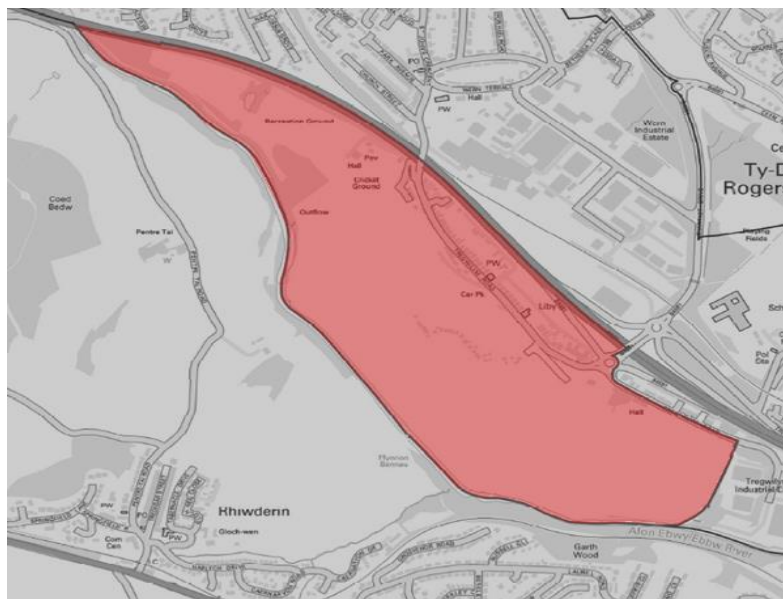
Dear Stakeholder

Re: Proposal to establish a new Primary School on the Jubilee Park development

You were advised on 15th November 2016 that the Council had launched a formal consultation on the proposal to establish a new primary school in Newport for pupils aged between 3 and 11 years, on the Jubilee Park housing development, with effect from September 2017.


Page 14 of the formal consultation pack includes a pictorial representation of the catchment area for the proposed new school. It has since been identified however that this image is incorrect as it includes only part of the Jubilee Park estate.

The catchment area for the proposed new school is in fact the entire Jubilee Park development, plus the section of Tregwilym Road between the Tregwilym Lodge Nursing Home and the railway bridge. The correct image is shown below:



No existing properties within the neighbouring Rogerstone Primary School catchment area are affected by this, but I hope this letter clarifies any confusion that has been caused.

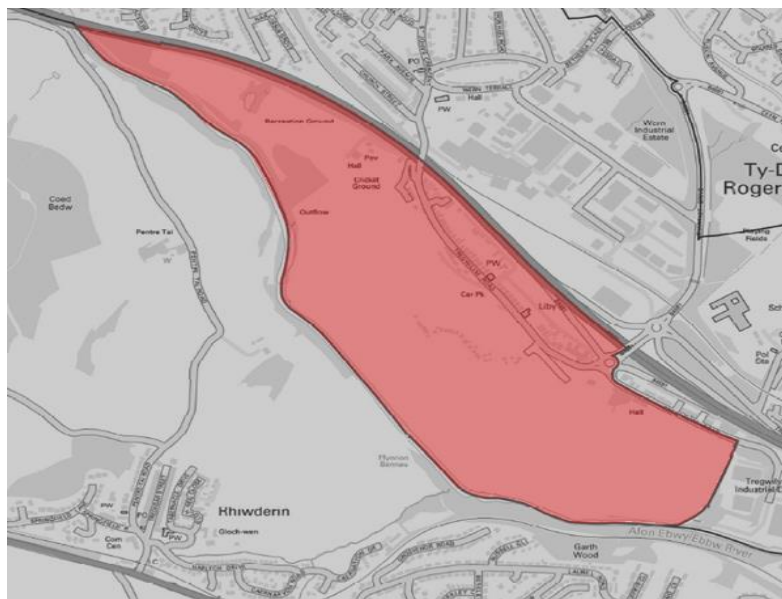
