Statutory Notice – School Standards and Organisation (Wales) Act 2013

Notice is given in accordance with sections 42 and 43 of the School Standards and Organisation (Wales) Act 2013 and the School Organisation Code that Newport City Council, having consulted such persons as required, proposes to establish a new 3-11 primary school at the premises currently known as Milton Infant School, Hendre Farm Drive, Newport, NP19 9HB and Milton Junior School, Hendre Farm Drive, Newport, NP19 9HB by extending the age range of Milton Infant School from 3-7 years to 3-11 years, and discontinuing Milton Junior School.

The new primary school will have a published admission number of 90, and capacity for 630 mixed-sex pupils aged between 4 and 11 years. In addition, there will be a nursery class for 64 full-time equivalent pupils, delivered over either a morning or afternoon session. It is proposed to implement the proposal on 1st September 2017.

The new school will be an English-medium community-maintained provision, and Newport City Council will be the admission authority. It is not proposed that the admission arrangements will make any provision for selection by aptitude or ability. Parents of children who are admitted for nursery education will still need to apply for a place at the school if they want their child to transfer to a Reception class.

The Council undertook a period of consultation before deciding to publish this proposal. A consultation report, containing a summary of the issues raised by consultees and the proposer's response and the views of Estyn, is available on the Newport City Council website at www.newport.gov.uk/schoolreorg

The Council has a Home to School Transport policy and provides free transport to eligible pupils of statutory school age. This provision will not be affected by this proposal. Further information in relation to this policy is available on the Council website.

Objection Period

Within a period of 28 days after the date of the publication of these proposals, that is to say by 1st February 2017, any persons may object in writing or by email to the proposals. The Council will publish a summary of any such objections made (and not withdrawn in writing) within the objection period, together with their observations thereon, at the time of notification to stakeholders of the determination of the proposal.
