

**NEWPORT CITY COUNCIL**  
**(CORN STREET, SKINNER STREET AND UPPER DOCK STREET, NEWPORT)**  
**(TEMPORARY ON-STREET WAITING AND LOADING RESTRICTIONS) ORDER 2021**

NOTICE is hereby given that Newport City Council in exercise of its powers under the Road Traffic Regulation Act 1984 (as amended) and all other enabling powers has made an order the effect of which is as described in the Schedule Parts 1 and 2 below.

The reason for making the order is to ensure public safety by reallocating road space for social distancing purposes. The order will come into operation on 12 February 2021 and will continue in force for a period not exceeding 18 months or until the national social distancing requirements cease, whichever is the earlier. Emergency vehicle access will be available. The order and a map showing the affected roads can be requested by emailing [conveyancing.team@newport.gov.uk](mailto:conveyancing.team@newport.gov.uk).

**SCHEDULE**

Part 1 - Suspension

The Newport City Council (Prohibition and Restriction of Waiting and Loading and On-Street Parking Places) (Civil Enforcement ) Order 2019 Schedule 1 shall be suspended and shall have no effect insofar as its provisions relate to the following lengths of roads:

- i) Corn Street (between Skinner Street and Upper Dock Street),
- ii) Skinner Street (between Upper Dock Street and Corn Street), and
- iii) Upper Dock Street (between Corn Street and Skinner Street).

Part 2 - Restrictions on the following lengths of roads:

No waiting or loading at any time-

- i) Corn Street – southeast side, from its junction with Skinner Street to a point 23 metres southwest of that junction, and from a point 41 metres southwest of its junction with Skinner Street to a point opposite the south western kerbline of Upper Dock Street.
- ii) Corn Street – northwest side, between its junctions with Skinner Street and Upper Dock Street.
- iii) Skinner Street – north side, from its junction with Upper Dock Street to a point 13 metres east of that junction, and from its junction with the access to the Newport City Bus Station(Market Street) for a distance of 31 metres in a southerly and westerly direction.
- iv) Skinner Street – South side, between its junctions with Upper Dock Street and Corn Street.
- v) Upper Dock Street – northeast side, between its junctions with Corn Street and Skinner Street.
- vi) Upper Dock Street – southwest side, from its junction with Corn Street to a point 12 metres northwest of that junction, and from its junction with Skinner Street to a point 8 metres south of that junction.

Loading only-

Corn Street – southeast side, from a point 23 metres southwest of its junction with Skinner Street to a point 41 metres southwest of that junction.

Disabled badge holders only-

Skinner Street – north side, from a point 13 metres east of its junction with Upper Dock Street to a point 31 metres south and west of the access to Newport City Bus Station (Market Street).

Hackney carriage vehicles only -

Upper Dock Street – southwest side, from a point 12 metres northwest of its junction with Corn Street to a point 20 metres southeast of its junction with Skinner Street.

Daw'r gorchymyn hwn i rym ar 12 Chwefror 2021 a bydd yn parhau mewn grym am gyfnod hyd at o 18 mis neu tan bo'r gofynion cenedlaethol o ran cadw pellter cymdeithasol wedi dod i ben, pa un bynnag fydd gyntaf. Rhan 1 - Dirymu

Bydd Atodlen 1 Gorchymyn Cyngor Dinas Casnewydd (Gwahardd a Chyfyngu ar Aros a Llwytho a Mannau Parcio ar y Stryd) (Gorfodi Sifil) 2019 yn cael ei dirymu ac ni fydd yn cael unrhyw effaith i'r graddau y mae ei darpariaethau'n ymwneud â'r rhannau canlynol o ffyrdd:

- i) Corn Street, (rhwng Skinner Street ac Upper Dock Street),
- ii) Skinner Street (rhwng Upper Dock Street a Corn Street), ac
- iii) Upper Dock Street (rhwng Corn Street a Skinner Street).

Rhan 2 - Cyfyngiadau ar y rhannau canlynol o ffyrdd:

Dim aros na llwytho ar unrhyw adeg -

- i) Corn Street – ochr y de-ddwyrain, o'r gyffordd â Skinner Street i bwynt 23 metr i'r de-orllewin o'r gyffordd honno, ac o bwynt 41 metr i'r de-orllewin o'r gyffordd â Skinner Street i bwynt gyferbyn ag ymyl cwrbyn palmant de-orllewinol Upper Dock Street.
- ii) Corn Street – ochr y gogledd-orllewin, rhwng y cyffordd â Skinner Street ac Upper Dock Street.
- iii) Stryd Skinner – ochr y gogledd, o'r gyffordd ag Upper Dock Street i bwynt 13 metr i'r dwyrain o'r gyffordd honno, ac o'r gyffordd â'r mynediad i Orsaf Fysiau Dinas Casnewydd (Market Street) am 31 metr tua'r de a'r gorllewin.
- iv) Skinner Street – ochr y de, rhwng y cyffordd ag Upper Dock Street a Corn Street.
- v) Upper Dock Street – ochr y gogledd-ddwyrain, rhwng y cyffordd â Corn Street a Skinner Street.
- vi) Upper Dock Street – ochr y de-orllewin, o'r gyffordd â Corn Street i bwynt 12 metr i'r gogledd-orllewin o'r gyffordd honno, ac o'r gyffordd â Skinner Street i bwynt 8 metr i'r de o'r gyffordd honno.

Llwytho yn unig -

Corn Street - ar ochr y de-ddwyrain, o bwynt 23 metr i'r de-orllewin o'r gyffordd â Skinner Street i bwynt 41 metr i'r de-orllewin o'r gyffordd honno.

Deiliaid bathodynau anabl yn unig -

Skinner Street – ochr y gogledd, o bwynt 13 metr i'r dwyrain o'r gyffordd gydag Upper Dock Street i bwynt 31 metr i'r de a'r gorllewin o'r mynediad i Orsaf Fysiau Dinas Casnewydd (Market Street).

Cerbydau hacni'n unig: -

Upper Dock Street – ochr y de-orllewin, o bwynt 12 metr i'r gogledd-orllewin o'r gyffordd â Corn Street i bwynt 20 metr i'r de-ddwyrain o'r gyffordd â Skinner Street.
