

**NEWPORT CITY COUNCIL
(MENDALGIEF ROAD, NEWPORT)
(TEMPORARY PROHIBITION OF WAITING AND SCHOOL KEEP CLEAR MARKINGS)
ORDER 2021**

NOTICE is hereby given that Newport City Council in exercise of its powers under the Road Traffic Regulation Act 1984 (as amended) and all other enabling powers intends not less than 7 days from the date of this notice to make an order the effect of which will be as described in the Schedule Parts 1 & 2 below. The reason for making the order is to improve road safety on Mendalgief Road outside the Connect Centre (formerly known as the YMCA building) which is being used as school premises for a temporary period. The order will come into operation on 31 August 2021 and will continue in force for a period not exceeding 18 months. The draft order and a map showing the affected roads can be requested by email: conveyancing.team@newport.gov.uk.

SCHEDULE

Part 1 – Prohibition of Waiting At Any Time (Double Yellow Lines)

Southern side of Mendalgief Road, from outside the property boundary between No.21 Mendalgief Road and the Connect Centre school entrance, for a distance of 31 metres in a south-easterly direction.

Part 2 – Prohibition of Stopping and Waiting (School Keep Clear Markings) Southern side of Mendalgief Road, from the point where the prohibition of waiting at any time restrictions (in part 1 of this Schedule) terminate, for a distance of 25.6 metres in a south-easterly direction. To prevent stopping and waiting outside the Connect Centre school entrance and to operate between 8:00am to 4:30pm, Monday to Friday, during the dates 1st September to 31st July each year.

(GWAHARDDIAD AROS DROS DRO A MARCIAU YSGOL CADWCH YN GLIR) 2021

Hysbysir drwy hyn fod Cyngor Dinas Casnewydd, wrth arfer ei bwerau dan Ddeddf Rheoleiddio Traffig Ffyrdd 1984 (fel y'i diwygiwyd) a'r holl bwerau galluogi eraill yn cynnig, mewn dim llai na 7 diwrnod o ddyddiad yr hysbysiad hwn, wneud gorchymyn a fydd yn gwneud yr hyn a ddisgrifir yn Rhannau 1 a 2 yr Atodlen isod.

Y rheswm dros wneud y gorchymyn yw gwella diogelwch ar y ffyrdd ar Mendalgief Road y tu allan i Ganolfan Connect (a elwid gynt yn adeilad YMCA) sy'n cael ei ddefnyddio fel safle ysgol am gyfnod dros dro. Bydd y gorchymyn yn dod i rym ar 31 Awst 2021 a bydd yn aros mewn grym am gyfnod o hyd at 18 mis. Rhan 1 – Gwahardd Aros Ar Unrhyw Adeg (Llinellau Melyn Dwbl)

Ochr ddeheuol Mendalgief Road, o'r tu allan i ffin yr eiddo rhwng Rhif 21 Mendalgief Road a mynedfa ysgol Canolfan Connect, am 31 metr i gyfeiriad y de-ddwyrain.

Rhan 2 - Gwahardd Stopio Ac Aros (Marciau Ysgol Cadwch Yn Glir)

Ochr ddeheuol Mendalgief Road, o'r man lle mae'r gwaharddiad ar aros ar unrhyw adeg (yn rhan 1 yr Atodlen hon) yn dod i ben, am bellter o 25.6 metr tua'r de-ddwyrain.
